Discovery operates on a Monthly Tuition basis. Monthly tuition is prepaid and is due on the 5th of each month. All children are placed in age appropriate morning programming regardless of the schedule chosen. Tuition fees are based on the schedule chosen as outlined below.

Monthly tuition remains the same whether or not a child is in attendance. We bill for 48 weeks a year, leaving 4 weeks (20 days) for center closures, holidays, sick days, and vacations. **WE DO NOT CREDIT SICK DAYS OR VACATIONS** unless special circumstances are present. If you should require child care on a day that you are not scheduled, we try to accommodate your needs. However, class size limits prohibit swapping/make-up days. Additional time needed beyond the base rate of the schedule chosen will be charged for on an hourly or daily rate as appropriate.

***We reserve the right to add a surcharge for children who are regularly at DDC more than 9.5 hours / day.

Registration: A \$50.00 per child registration fee, registration form, and current immunizations are required prior to initiation of services. This fee is non-refundable.

Tuition Deposit: A \$300.00 tuition deposit is required from all families. This deposit will be credited to the last month's bill that a family is enrolled when a **minimum of two weeks notice is given**, and Family Share obligation has been fulfilled.

Activity Fees: An annual \$50 per-child activity fee will be billed each September to help cover transportation costs for field trips, special events, and other classroom projects. This fee will be prorated for families enrolling after December. An additional summer activity fee, dependent on child schedule and age, will be billed each June for children participating in summer programming.

Family Share Program: Discovery is a non-profit 501(c)3 organization. Family participation is an important component of our program. This participation is formalized through our Family Share Program. Each family is asked to volunteer 15 hours per year (September through August calendar year). A program description and list of current projects is included in your registration packet. In lieu of volunteer time, you may make a \$300 contribution to Discovery, or you may choose a mix of volunteer hours and a \$20 per hour charge for unfilled hours. Unfilled hours will be deducted from \$300.00 tuition deposit the last month a child is enrolled.

Schedule/Contract Changes: Changes in contracted days and hours can usually be accommodated unless prohibited by class size. Tuition fees to reflect these changes will be included on the following month's bill as either an overtime charge for extra days or as a credit **if two weeks notice is given**. A new tuition contract may need to be completed.

Annual Tuition Increase: Annual tuition increases occur at the beginning of each new school year in – reflected in June or September bills, depending on enrollment period. This annual increase allows Discovery to retain quality staff, and keep up with the increasing costs of doing business.

Finance Charges: Account balances left unpaid after the 15th of the month will incur a \$5.00 rebilling charge. Child care could also be discontinued at this point. A finance charge (18% annual, \$5.00 minimum) will be incurred after 30 days. In the event that an unpaid balance is placed for collections with any third party collection agency, a fee of 50% of your outstanding balance will be applied to your account. This amount shall be in addition to any other costs incurred directly or indirectly to collect amounts owed under this agreement including attorney fees, late fees, and all other fees stated elsewhere.
